 \Box I agree to observe and be bound by both the Rules and Manual including any amendments to either document or additions of any Policies and / or Procedures. They form part of this contract. I recognize that GO₂'s Board of Directors may amend the Manual and that GO₂'s members may amend the Rules.

 \Box If my application is accepted, GO₂ will, subject to all the terms and conditions in the Manual and this application:

• provide me with access to vehicles owned or leased by it ("Co-op Vehicles"), and

• pay for Co-op Vehicle-related expenses such as gas, tires, maintenance and certain repairs, unless otherwise specified.

 \Box I understand that GO₂ will endeavor to ensure vehicles are clean, reliable and well maintained and will periodically inspect the Co-op Vehicles. However, I recognize that:

• members share responsibility for the maintenance and safety of Co-op Vehicles;

• GO₂'s periodic inspection of the vehicles is supplementary to the inspection of vehicles by members;

• as a member I will be responsible for ensuring the safe condition of any Co-op Vehicle that I drive; and

• GO_2 does not make any representations or warranties as to the fitness or condition of any Co-op Vehicle.

 \Box I recognize that the Manual and Rules state when I will be responsible for paying various fees, expenses, liens, and fines. I agree that this money will be a debt due and payable to GO₂ and that GO₂ will have a lien on my shares to cover the full amount owing. Any amount due and payable may be set off against my share balance, and will only be restored once all debts have been paid. (For Associate Members, debts due and owing to GO₂ will also form a lien against the shares owned by their Full Member Partner, and for Full Members with a partner who is an Associate Member, debts due and owing by the Full Member will also form a lien against the shares owned by their partner.)

 \Box I understand that GO₂ will ensure that Co-op Vehicles are insured for liability, the details of which are available from GO₂. I recognize that GO₂ will only be liable to me for any damages arising out of my use of a Co-op Vehicle if GO₂'s gross negligence has caused the damages. I waive any right I have to sue or make claims against GO₂ and its directors, officers, employees or members for damages arising from the fitness or condition of a Co-op Vehicle, except in cases of gross negligence. I also waive any right I have to sue or make claims against GO₂ and its directors, officers, employees or members for a vehicle not being available at the time it was booked.

 \Box I recognize that I am not a representative, agent or employee of GO₂ except to the extent that GO₂'s Board of Directors has empowered me to act as a representative, agent or employee.

 \Box In order to be considered for membership with GO₂ I understand:

- I must have a good credit rating;
- I must have three years of driving history;
- I must have had no at-fault accidents in the last three years;
- I must have three or fewer road tickets in the last three years; and
- I must have no criminal convictions under the motor vehicle act.
